ORDER

The Government of Kerala has established the Kerala Technological University (KTU) vide Ordinance read as paper 1. As per the Government Order read as paper 2, all Institutions imparting education in Engineering and Technology in the State of Kerala shall disaffiliate from the existing Universities and affiliate with the Kerala Technological University and that, all Technical Institutions in the State will mandatorily affiliate with the Kerala Technological University for the conduct of B.Tech and M.Tech Courses from the Academic Year 2015-16 onwards. Invoking the powers conferred under Section 11(11) of the CUSAT Act 1986, sanction is accorded by the Vice-Chancellor to implement the Government Order in the University, subject to ratification by the Syndicate as per reference read (3). Accordingly, the B.Tech and M.Tech programmes of the following Colleges will disaffiliate from the University from the Academic Year 2015-16.

The B.Tech/M.Tech students admitted to the disaffiliating Colleges from the Academic Year 2015-16 onwards will not be registered with CUSAT. However, the existing students, ie., the students who are already registered with CUSAT will continue with the University.

CUSAT will not conduct Annual Inspection for granting extension of recognition in the disaffiliating Institutions from the Academic Year 2015-16 onwards for the B.Tech/M.Tech Courses. The disaffiliating Institutions have to remit the proportionate amount towards Annual Recognition fee to CUSAT as noted below, for the aforesaid courses.
