The programs have been granted accreditation for 3 years. **TOC H Institute of Science and Technology, Arakunnam, Ernakulam Pin-682313 Kerala** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
- 5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to TOC H Institute of Science and Technology, Arakunnam, Ernakulam Pin-682313 Kerala as a whole.
